The Board of Directors Meeting of Finansa Public Company Limited (the "Company") No. 6/2020 held on September 15, 2020 at 48/48 Tisco Tower, North Sathorn Road, Bangkok resolved as follows:

1. Approved the payment of an interim dividend from the Company's net profit and retained earning as at June 30, 2020 of THB 0.15 per share, totaling THB 51.88 Million to shareholders. The Record Date for specifying the list of shareholders entitled to receive dividends will be October 1, 2020 and the dividend will be paid on October 9, 2020. (The dividend recipients shall not receive tax credit as the payment shall be paid from tax exempted income.)
2. Acknowledged the resignation of Mr. Eugene S.Davis from his directorship as he viewed that he had reached retirement age. In this regard, Mr. Kittipong Lertvanangkul has been appointed as a Director to replace Mr. Eugene S.Davis with effect from September 15, 2020 onwards.
