  - (d) an opinion on the suitability of the auditor,
  - (e) an opinion on transactions that may lead to conflicts of interests,
  - (f) the number of Audit Committee meetings, and the attendance at such meetings by each committee member,
  - (g) an opinion or overview comment received by the Audit Committee from its performance of duties in accordance with the charter, and
  - (h) other transactions which, according to the Audit Committee's opinion, should be known to the shareholders and general investors, subject to the scope of duties and responsibilities assigned by the Company's board of directors; and
- 8) To perform any other act as assigned by the Company's Board of Directors, with the approval of the Audit Committee.
